  5. Whether the Government of India Department of Publication /Directorate of Printing maintains any record showing the date & time of receipt of communication received from various departments/ministries for publication in Gazette and Gazette Extraordinary?
  6. When did Government of India Department of Publication /Directorate of Printing receive information for publishing G. Nos. 33 (312GI/2014) and 312 (5503GI/2013)? Please provide a copy of the page of the record which shows the entry for receipt of information from Directorate of Safeguards published in Gazette No. 33 (312GI/2014) and 312 (5503GI/2013).
  7. How does Government of India Department of Publication /Directorate of Printing confirm the authenticity and veracity of the information provided by Departments/Ministries for publication? How does the Government of India Department of Publication /Directorate of Printing ensure that the information received by it is already approved for publication by the concerned Department/Ministry for publication that sends the information for publication?
  8. At what time was the printing material (paper, ink, etc.) and allotment of manpower done to publish G. Nos. 33 (312GI/2014) and 312 (5503GI/2013)? Kindly furnish a copy of the record that shows the respective stock and manpower allocations.
  9. Who was in-charge of printing machine and circulation of Extraordinary Gazettes bearing G. Nos. 33 (312GI/2014) and 312 (5503GI/2013)?
  10. What are the timings of printing and circulation for Extraordinary Gazettes bearing G. Nos. 33 (312GI/2014) and 312 (5503GI/2013)?
  11. When was the Gazette published and delivered to Kitab Mahal office for sale to general public?
