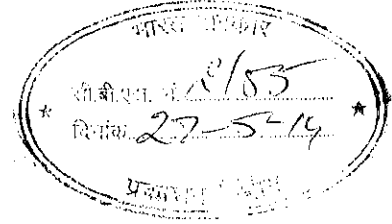

complete in all respects and ready for publication. Kindly also clarify and explain what steps by the Directorate of Printing are taken to ensure that a notification which has been printed is ready for publication.

3. Kindly provide the date on which the properly printed version of Initiation Notification No. 15/29/2013 dated 31.12.2013, assigned Job No. 5503 GI/13, was transferred and sent to the Directorate of Publishing. If the above Notification was printed, complete in all respects and sent for publishing on 6.1.2014, kindly issue an express statement attesting to the same.
4. Kindly explain the practice of dating notifications by the Government of India. For instance, if a notification dated 31.12.2013 was printed, deemed to be complete in all respects and sent for publication on a date later than 31.12.2013, kindly explain why such notification is dated 31.12.2013.
