CIRCULAR

Applications are invited from the eligible candidates who may be desirous for being considered for the post of Cashier in the pay scale of Rs. 5200-20200 / - + G.P. 2800/- plus usual allowance as admissible under the rules. The selected candidates will be required to furnish requisite cash security and to execute the prescribed bond before appointment to the post.

The eligibility of selection for the post of cashier is as under:-

Deputation: Officers of the Central Government:

- (i) Holding analogous post on regular basis ; or
- (ii) With five years regular service in the grade of Upper Division clerk or equivalent.

Note 1: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.

The maximum age limit for appointment by deputation shall be 'Not exceeding 56 years' as on the closing date of receipt of applications.


Note 2 : The departmental officers who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation . Similarly the deputation is to shall not be eligible for consideration for appointment by promotion.

Note 3 : For purpose of appointment on deputation /absorption basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission

recommendation has been extended) shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay/ Pay scale and where this benefit will extend only for the post or posts for which that grade Pay or Pay Scale is the normal replacement grade without any upgradation.

The eligible applicants from other Govt. Departments should send their applications through proper channel along-with 5 years ACRs/ APARs, Vigilance clearance and Integrity certificate. The application should reach the undersigned within 60 days from the date of issue of the circular. No Application will be entertained after the stipulated date is over.
